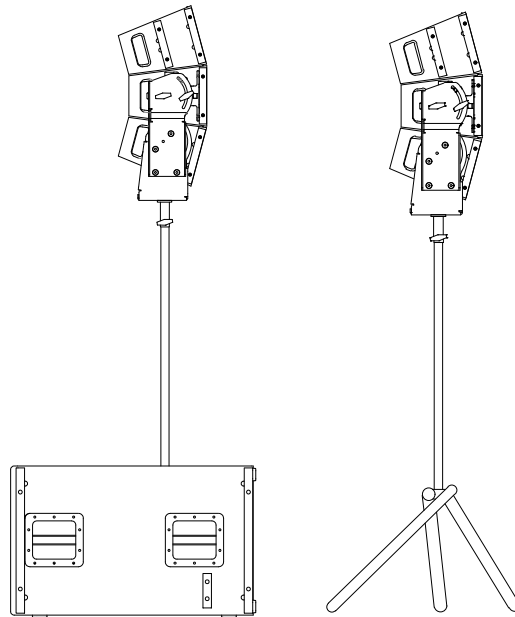

FOR VERTEC SUBCOMPACT SYSTEMS
USER GUIDE



IMPORTANT SAFETY INSTRUCTIONS

1. Read these instructions.
2. Keep these instructions.
3. Heed all warnings.

5. Do not use this apparatus near water.
6. Clean only with a dry cloth.
7. Do not block any ventilation openings. Install in accordance with manufacturer's instructions.
8. Do not install near any heat sources such as radiators, heat registers, stoves, or other apparatus that produce heat.
9. Only use attachments / accessories specified by the manufacturer.
10. Use only with a cart, stand, tripod, bracket, or table specified by the manufacturer or sold with the apparatus. When a cart is used, use caution when moving the cart / apparatus combination to avoid injury from tip-over.

PRECAUTIONS

The VerTec series speakers covered by this manual are not intended for use in high moisture environments. Moisture can damage the speaker cone and surround and cause corrosion of electrical contacts and metal parts. Avoid exposing the speakers to direct moisture. Keep speakers out of extended or intense direct sunlight. The driver suspension will prematurely dry out and finished surfaces may be degraded by long-term exposure to intense ultra-violet (UV).

Vertec Subcompact Series speakers can generate considerable energy. When placed on a slippery surface such as polished wood or linoleum, the speaker may move due to its acoustical energy output. Precautions should be taken to assure that the speaker does not fall off a stage or surface on which it is placed.

STAND MOUNTING SAFETY PRECAUTIONS

The VT4886-UB includes a pole mount adapter to allow mounting on tripod stands or on an extension rod (pole) over subwoofers. When using stands or poles, be sure to observe the following precautions:

- Check the stand or pole specification to be certain the device is designed to support the weight of the speaker. Observe all safety precautions specified by the manufacturer.
- Always verify that the stand (or subwoofer/pole) is placed on a flat, level and stable surface and be sure to fully extend the legs of tripod type stands. Position the stand so that the legs do not present a trip hazard.
- Route cables so that performers, production crew, and audience will not trip and topple the speakers.
- Inspect the stand (or pole and associated hardware) before each use and do not use equipment with worn, damaged, or missing parts.
- Do not attempt to place more than three VT4886 loudspeakers on a stand or pole.

- When mounting VT4886 loudspeakers on a pole or tripod, integral suspension hardware must be used to secure the speakers to each other. Only the correct quick release pins and hardware supplied by JBL are to be used.
- Always be cautious when deploying the system outdoors. Unexpected winds may topple a system. It may be necessary to place additional weight (e.g., sandbags) on the base of the stand to improve stability. Avoid attaching banners or similar items to any part of a speaker system. Such attachments could act as a sail and topple the system.
- Unless you are confident that you can handle the weight of the speaker, ask another person to help you get it onto the tripod stand or pole.
- Using the VT4886-UB, up to three VT4886 cabinets may be mounted on a JBL SS2-BK tripod stand or with the SS4-BK or SS5-BK adjustable pole mount or extension rod to their companion VT4883 subwoofers.

SUSPENSION OF LOUDSPEAKER SYSTEM

Before attempting to suspend your JBL loudspeakers, read and understand the following safety information.

All information presented herein is based upon materials and practices common to North America and may not directly apply to other countries because of differing material dimensions, specifications, and/or local regulations. Users in other countries should consult with appropriate engineering and regulatory authorities for specific guidelines.

Correct use of all included hardware is required for secure system suspension. Careful calculations should always be performed to ensure that all components are used within their working load limits before the array is suspended. Never exceed the maximum recommended load ratings.

Before suspending any speaker system always inspect all components (enclosure, rigging frames, pins, eyebolts, track fittings, etc.) for cracks, deformations, corrosion, missing, loose or damaged parts that could reduce strength and safety of the array. Do not suspend the speaker until the proper corrective action has been taken. Use only load-rated hardware when suspending JBL suspendable loudspeaker models.

ARE YOU NEW TO RIGGING?

If you are new to rigging, you should do the following:

- Read and study JBL Technical Note Volume 1, Number 14: Basic Principles for Suspending Loudspeaker Systems (available at http://www.jblpro.com/pub/technote/tn_v1n14.pdf)
- Know the rules for safe rigging.
- Attend a safe rigging seminar, such as that presented by professionals like Rigging Seminars™ (www.riggingseminars.com) or by Chain Motor Hoist manufacturers like Columbus McKinnon Corp. (manufacturers of the C/M Lodestar).
- Meet and establish a relationship with a licensed mechanical or structural engineer. Get in the habit of asking them questions instead of guessing about their answers. Learn from what they tell you.
- Meet and discuss this aspect of your business with your Insurance Agent.
- Research and understand the codes, practices, and requirements in the venues where you intend to operate your sound system.

GENERAL HARDWARE INFORMATION

Any hardware used in an overhead suspension application must be load rated for the intended use. Generally, this type of hardware is available from rigging supply houses; industrial supply catalogs and specialized rigging distributors. Local hardware stores do not usually stock these products. Hardware that is intended for overhead suspension will comply with ASME B30.20 and will be manufactured under product traceability controls. Compliant hardware will be referenced with a working load limit (WLL) and a traceability code.

ATTACHMENT TO STRUCTURES

A licensed Professional Engineer must approve the placement and method of attachment to the structure prior to the installation of any overhead object. The following performance standards should be provided to the Professional Engineer for design purposes; Uniform Building Code as applicable, Municipal Building Code as applicable, and Seismic Code as applicable.

The installation of the hardware and method of attachment must be carried out in the manner specified by the Professional Engineer. Improper installation may result in damage, injury or death.

INSPECTION & MAINTENANCE

Suspension systems are comprised of mechanical devices and, as such, they require regular inspection and routine maintenance to ensure proper function ability. Before suspending or pole mounting any speaker system always inspect all components (enclosure, suspension frames or brackets, pins, eyebolts, etc.) for cracks, deformations, corrosion, missing, loose or damaged parts that could reduce strength and safety of the array. Do not suspend or pole mount the speaker until the proper corrective action has been taken.

Installed systems should be inspected at least annually. The inspection shall include a visual survey of all corners and load bearing surfaces for signs of cracking, water damage, de-lamination, or any other condition that may decrease the strength of the loudspeaker enclosure.

Accessory suspension hardware provided with or for JBL VT4886 and VT4883 loudspeakers must be inspected for fatigue at least annually or as required by local ordinance. The inspection shall include a visual survey of the material for signs of corrosion, bending or any other condition that may decrease the strength of the fastener. Additionally, any eyebolts shall be checked for possible spin-out of the enclosure.

For all other hardware and fittings, refer to the hardware manufacturer's inspection and maintenance guidelines for process.

SAFE SUSPENSION

JBL suspendable version loudspeakers are supplied with built-in internal brackets. The systems are designed to facilitate the suspension of the loudspeaker by a qualified person familiar with rigging hardware and industry practices. Improper installation may result in damage, injury or death. If you are unfamiliar with Safe Rigging Practices you will need to consult with a qualified person familiar with rigging hardware and industry practices.

Working Load Limit for M10 Suspension Points

The working load limit (WLL) of any JBL suspendable loudspeaker system using the M10 attachment point will be maintained as long as no more than 470lbs/213kg from 2 points equally loaded or no more than 235lbs./ 106 kg from a single point maximum and as long as safe rigging practices are followed.

For permanent installation applications utilizing the M10 suspension points order JBL 229-00009-01. This kit includes three (3) M10 x 35 mm forged shoulder steel eyebolts with washers.

WARNING

Suspension of JBL loudspeakers must employ a minimum of two (2) attachment points. When "bridling" a JBL loudspeaker system, two (2) legs of equal length must be used. The rear attachment points are pull-back points and are intended only for use in adjusting the down-angle of the speaker enclosure. Only the top and bottom attachment points are intended for use as suspension points.

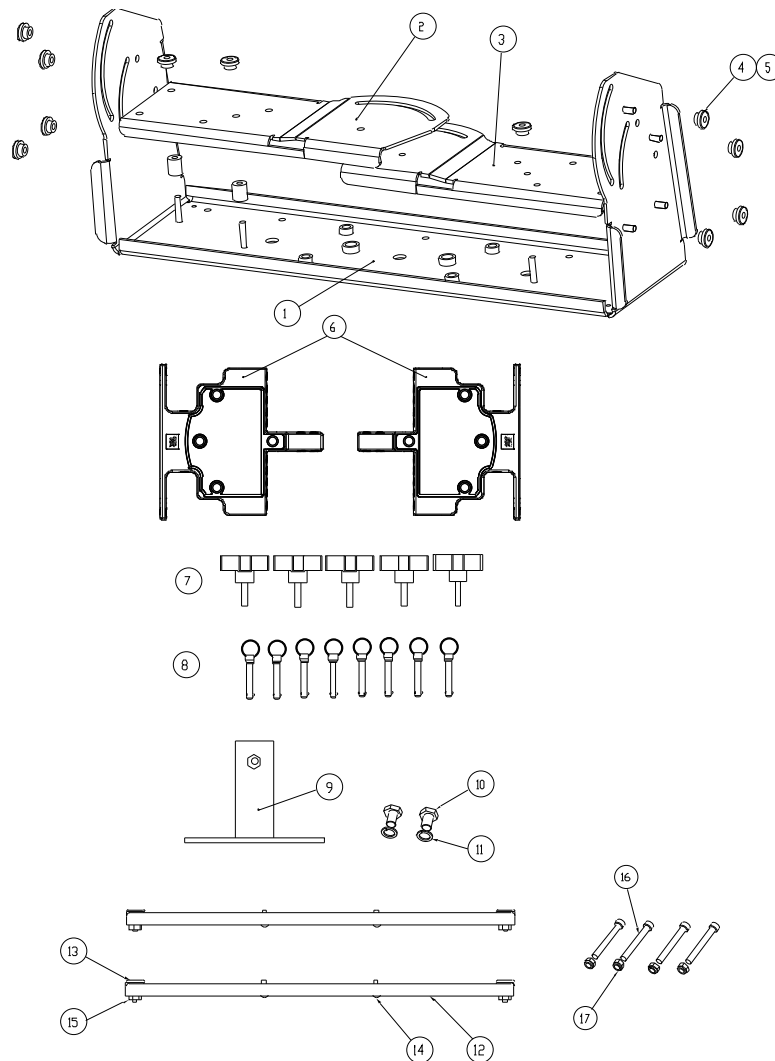


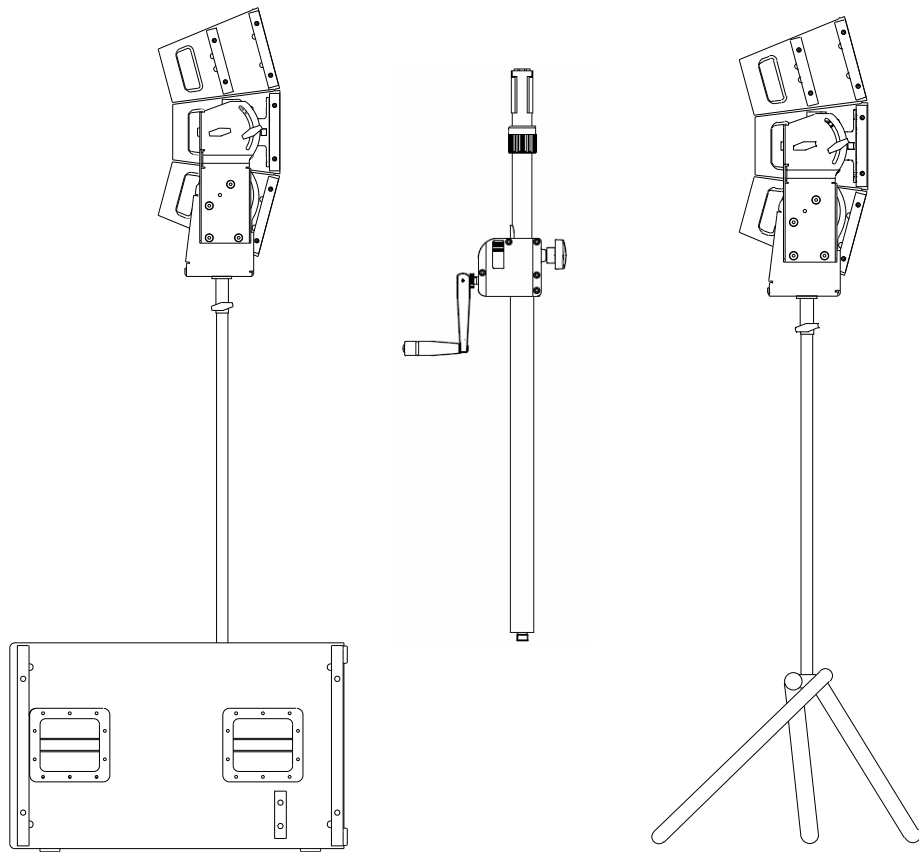
Figure 1: VT4886-UB UNIVERSAL BRACKET PACKAGE CONTENTS

 - M10 threaded inserts for attachment of supplied pole mount adapter

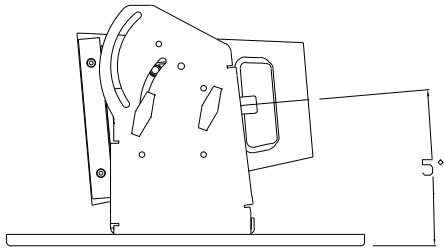

- Assembly can also be secured to subwoofers for stacked FOH or side fill applications
- Flexible attachment options:
 - Multiple pivot points and removable side extension plates provide a wide range of attachment options and tilt angle adjustment
 - Removable stabilizer legs provide improved stability for downwards or upwards orientation

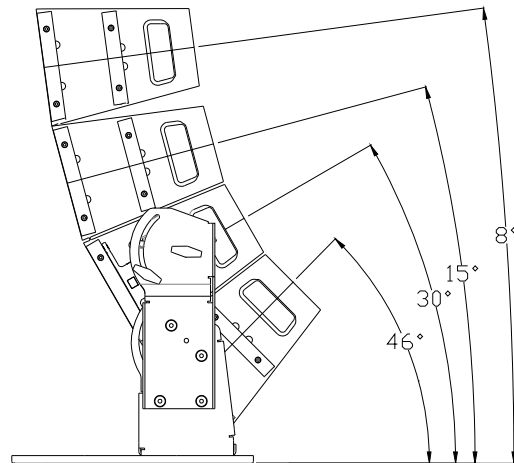
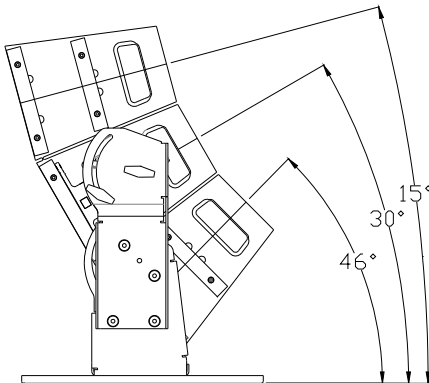
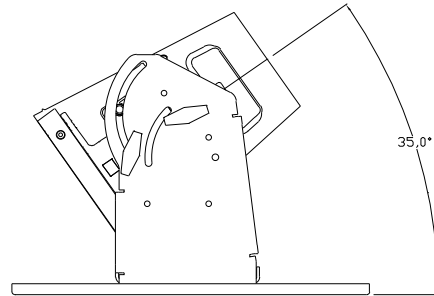


Figure 3: Side view of stacked front fill systems using VT4886-UB in yoke mode with supplied stabilizer legs. For larger arrays, shift stabilizer legs forwards to keep center of gravity centered on the stabilizer leg footprint.

STACKED MODE: STAGE MONITOR, DRUM FILL OR DJ MONITOR

- Can be used as a cradle for 1, 2, 3 or 4x VT4886 enclosures for stage monitoring
- Assembly can also be secured to subwoofers for drum fill or DJ monitoring
- Flexible attachment options:
 - Multiple pivot points and removable side extension plates provide a wide range of attachment options and tilt angle adjustment
 - Removable stabilizer legs provide improved stability for downwards or upwards orientation

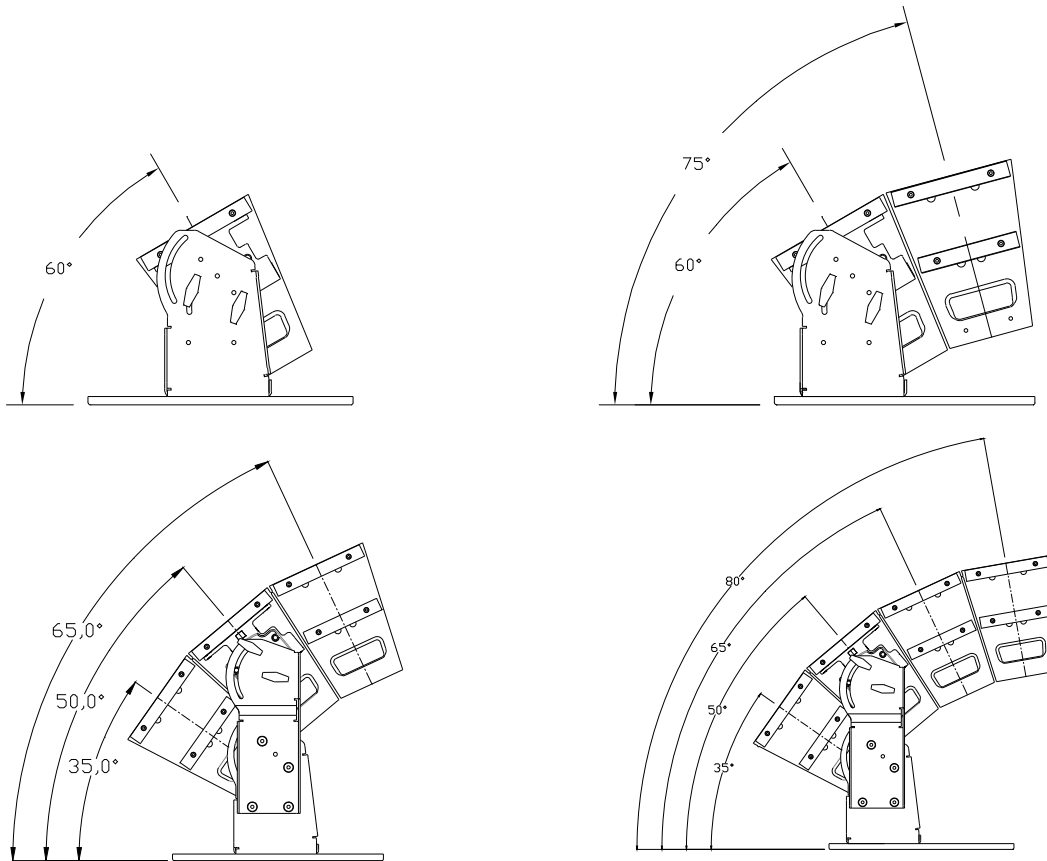


Figure 4: Side view of 1x, 2x, 3x, 4x VT4886 stacked systems using VT4886-UB in yoke mode with supplied stabilizer legs. For larger arrays, shift stabilizer legs backwards to keep center of gravity centered on the stabilizer leg footprint.

UNDER-BALCONY (SUSPENDED) MODE:

- Can be inverted for suspension of 1, 2, 3 or 4x VT4886 enclosures
- Flexible attachment options:
 - Multiple pivot points and removable side extension plates provide a wide range of attachment options and tilt angle adjustment
 - Central 0.53" (13.5 mm) diameter hole for attachment of drop down extension rod (not supplied) for pipe mounting using additional 3rd party accessories
 - Two 0.53" (13.5 mm) diameter holes available for eyebolt attachment
 - Ten mount holes (0.277" / 7.04 mm diameter) available on Universal Bracket base for permanent installation (see Figures 16 and 18 for details).

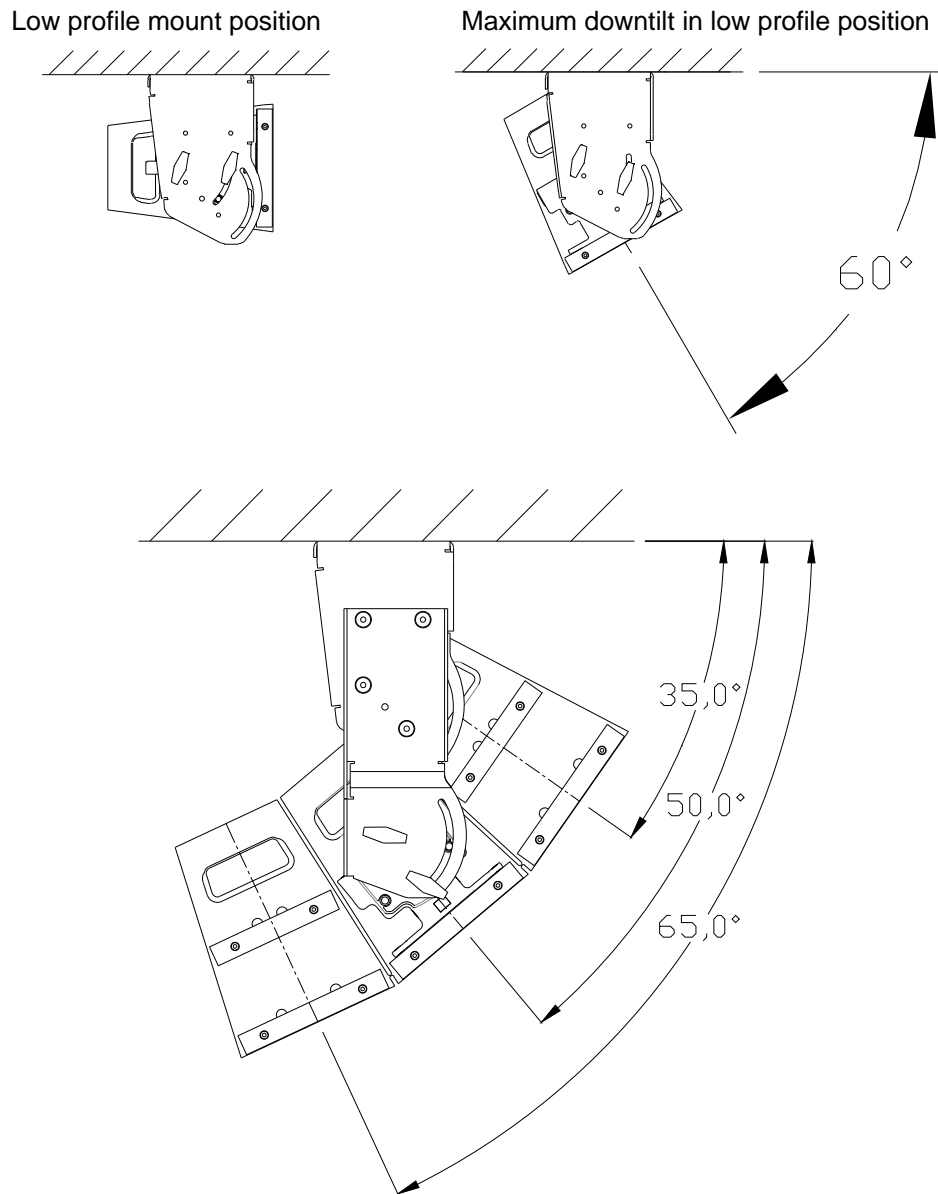


Figure 5: VT4886-UB under-balcony examples

OMNIMOUNT MODE

- Standard Omnimount bolt hole pattern with 4x 3/8 in x 16 threaded inserts available on Universal Bracket base
- For use with Omnimount 120.0 series accessories for up to 3x VT4886 enclosures
- For use with Omnimount 240.0 series accessories for up to 4x VT4886 enclosures

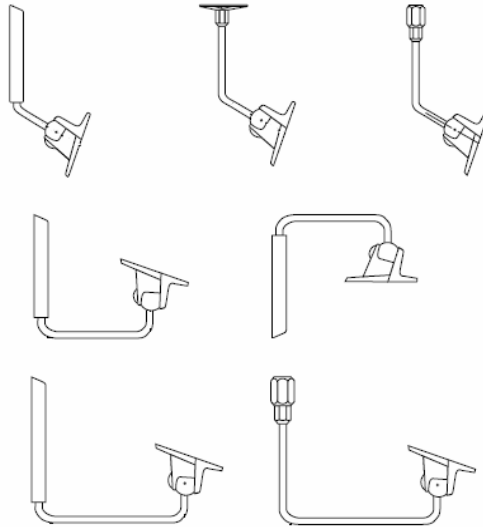


Figure 6: Optional Omnimount accessories, compatible with VT4886-UB

WALL-MOUNT MODE

- Can be used horizontally for wall mounting 1, 2 or 3x VT4886
- Flexible attachment options:
 - Multiple pivot points and removable side extension plates provide a wide range of attachment options and tilt angle adjustment
 - Ten mount holes (0.277" / 7.04 mm diameter) available on Universal Bracket base for permanent installation (see Figures 16 and 18 for details).

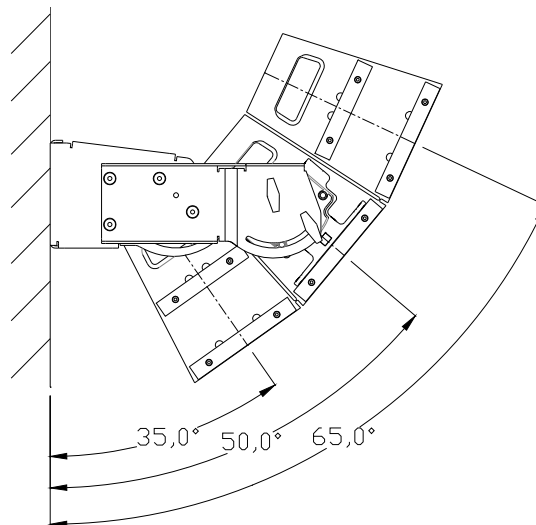


Figure 7: VT4886-UB in wall-mount mode

SPEAKER ATTACHMENT ADAPTER PLATE MOUNT PROCEDURE

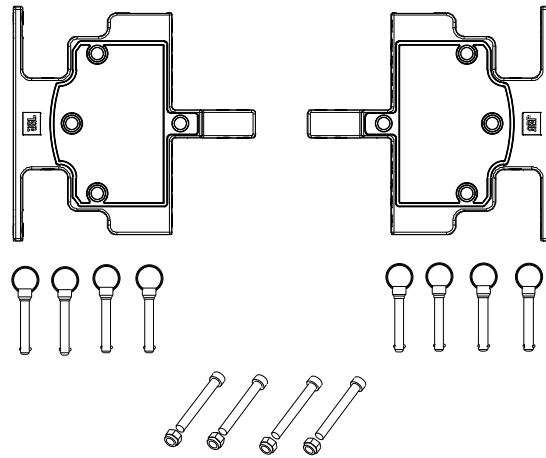


Figure 8: Left/Right Speaker Attachment Adapter Plates secure to VT4886 enclosure sides using supplied ball-lock pins. For suspended configurations or fixed installation, use #1/4-20 x 2" allen bolts and lock nuts for front attachment.



Remove all front and rear VT4886 quick release pins.

Store front VT4886 quick release pins in the interior holes available on Speaker Attachment Adapter Plate



Rotate the side adapter plate into position. Store rear VT4886 quick release pins in the available holes and secure Speaker Attachment Adapter Plates using the supplied ball lock pins.

Note: To allow attachment of additional enclosures, front and rear VT4886 hingebars should be extended prior to securing Speaker Attachment Adapter Plates



For suspension (under-balcony mode) or fixed installation, use supplied #1/4-20 x 2" allen head bolts and lock nuts for front attachment of Speaker Attachment Adapter Plates

SPEAKER ATTACHMENT ADAPTER PLATE TO UNIVERSAL BRACKET BASE MOUNT PROCEDURE

Speaker Attachment Adapter Plates mount to the Universal Bracket using the supplied handles (2 per side). The pivot point on the Speaker Attachment Adapter Plate attaches to the A (lower) or C (upper) pivot attachment points on the Universal Bracket (no side extension plates) or pivot attachment point E when side extension plates are used. Three hole positions are available on the Speaker Attachment Adapter Plate that align with angle adjustment slots on the Universal Bracket Base (B or D) or Side Extension Plates (F). The range of tilt adjustment for various attachment options is summarized in Tables 1 and illustrated in Figure 12.

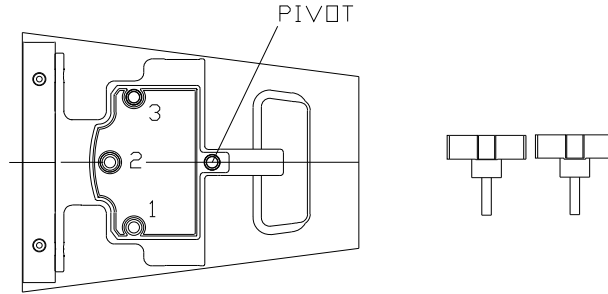


Figure 10: Speaker Attachment Adapter Plate detail showing pivot location and angle adjustment hole positions (1, 2, 3). Speaker Attachment Adapter Plates mount to VT4886-UB using 2 handles per side.

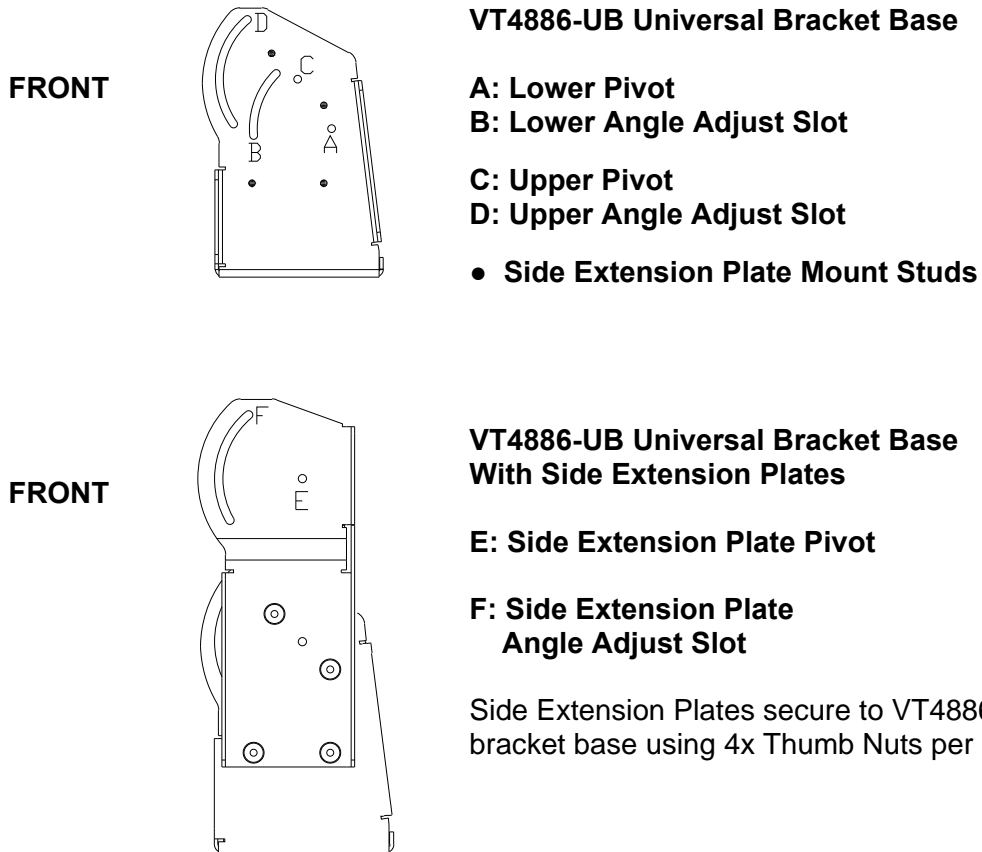


Figure 11: Universal Bracket Side Attachment Details (with and without extension plates)

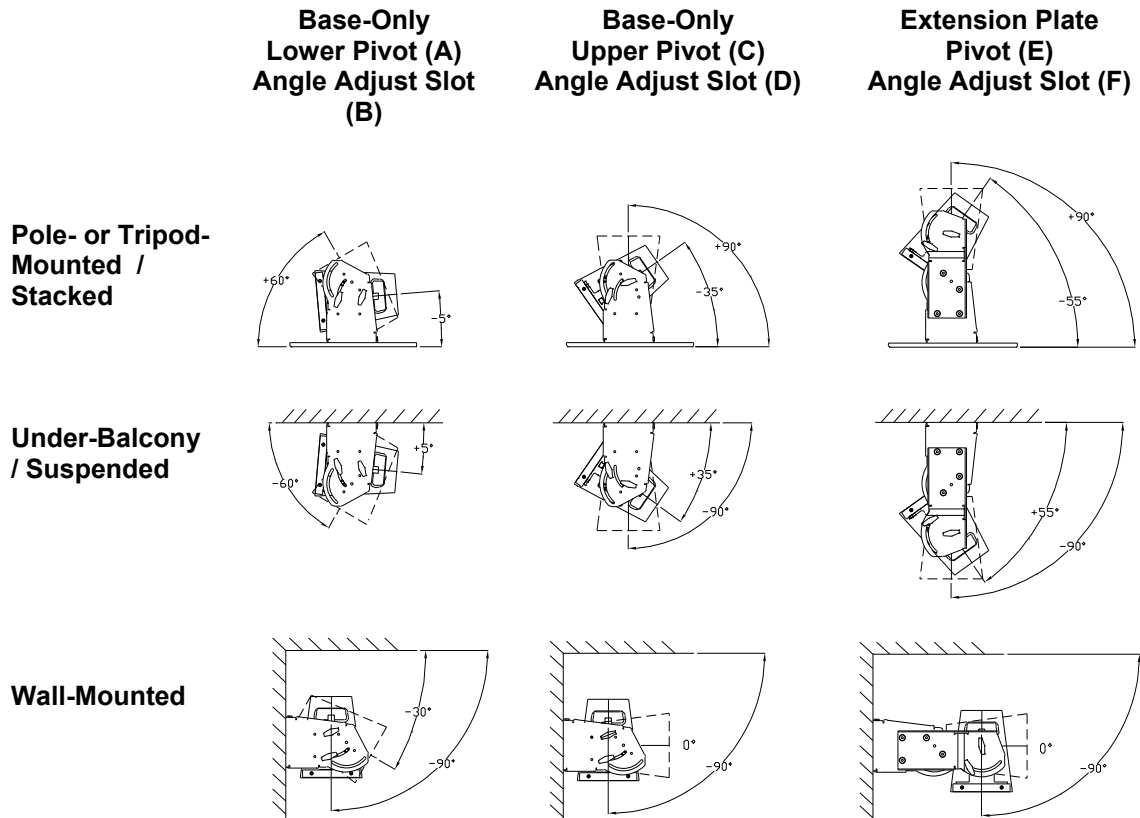


Figure 12: Maximum and Minimum Tilt Angles - Illustrated

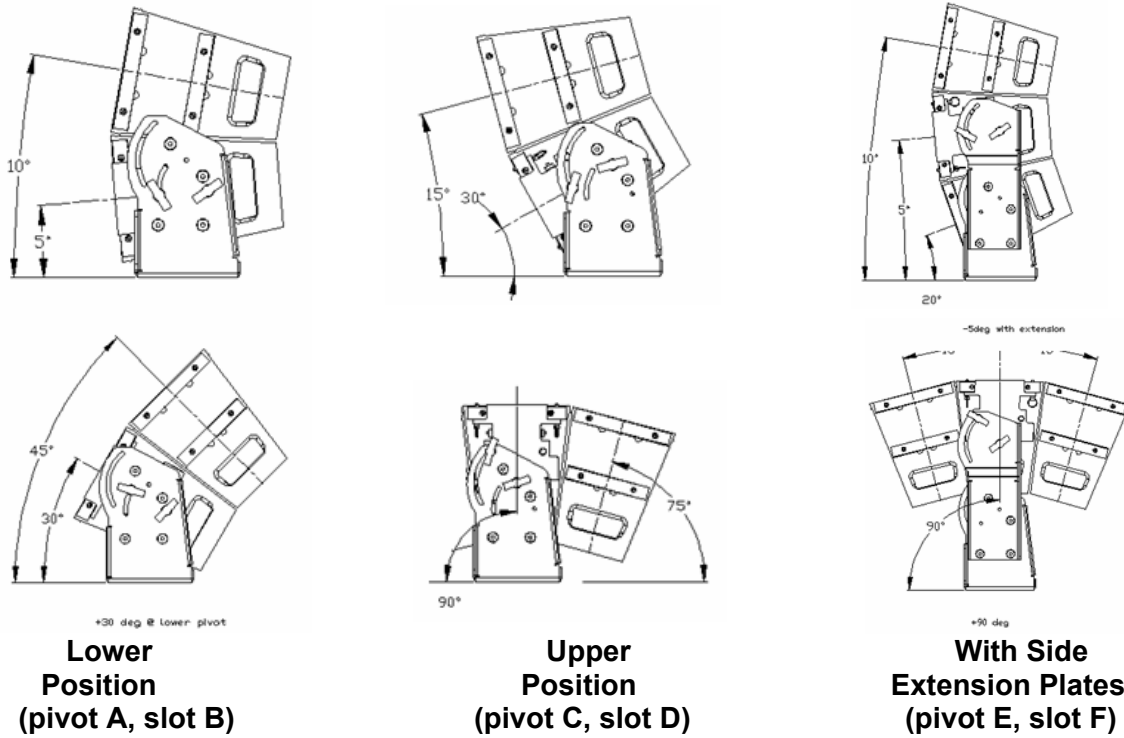


Figure 13: VT4886-UB Yoke Mode Examples (3 maximum : tripod-mounted, pole-mounted or omnimount)

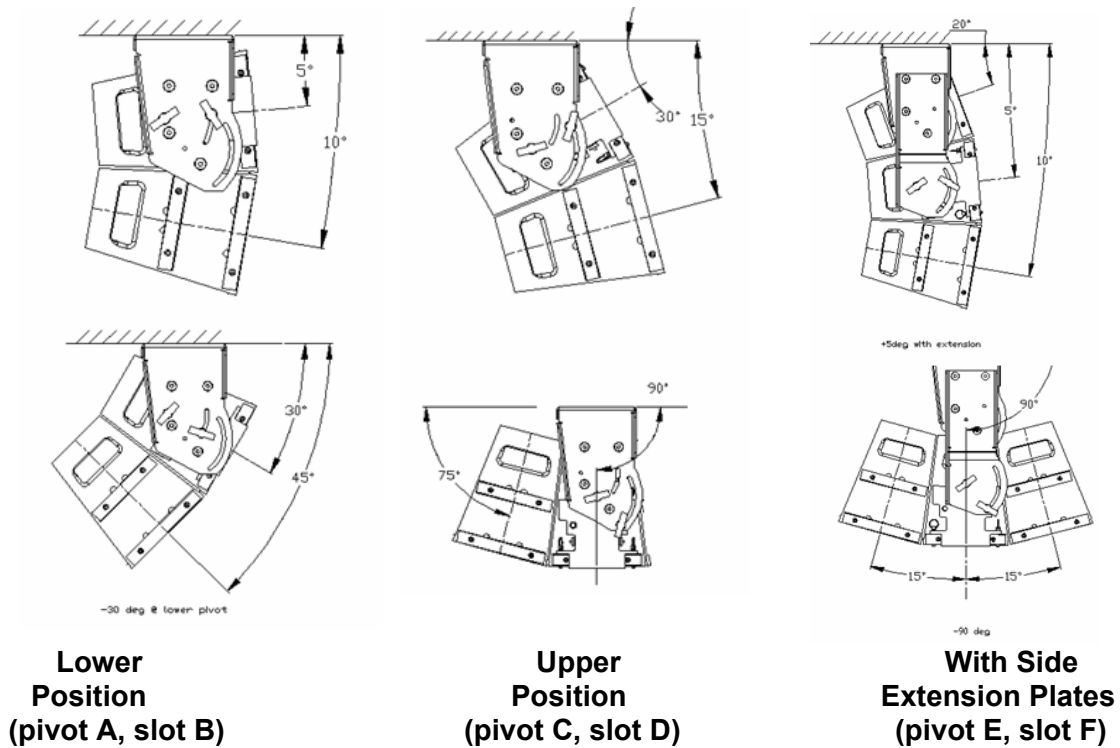


Figure 14: VT4886-UB Underbalcony Mode Examples (refer to Figures 16 and 18 for mounting options)
Also for use with 3rd party drop-down extension rod and pipe clamp accessories

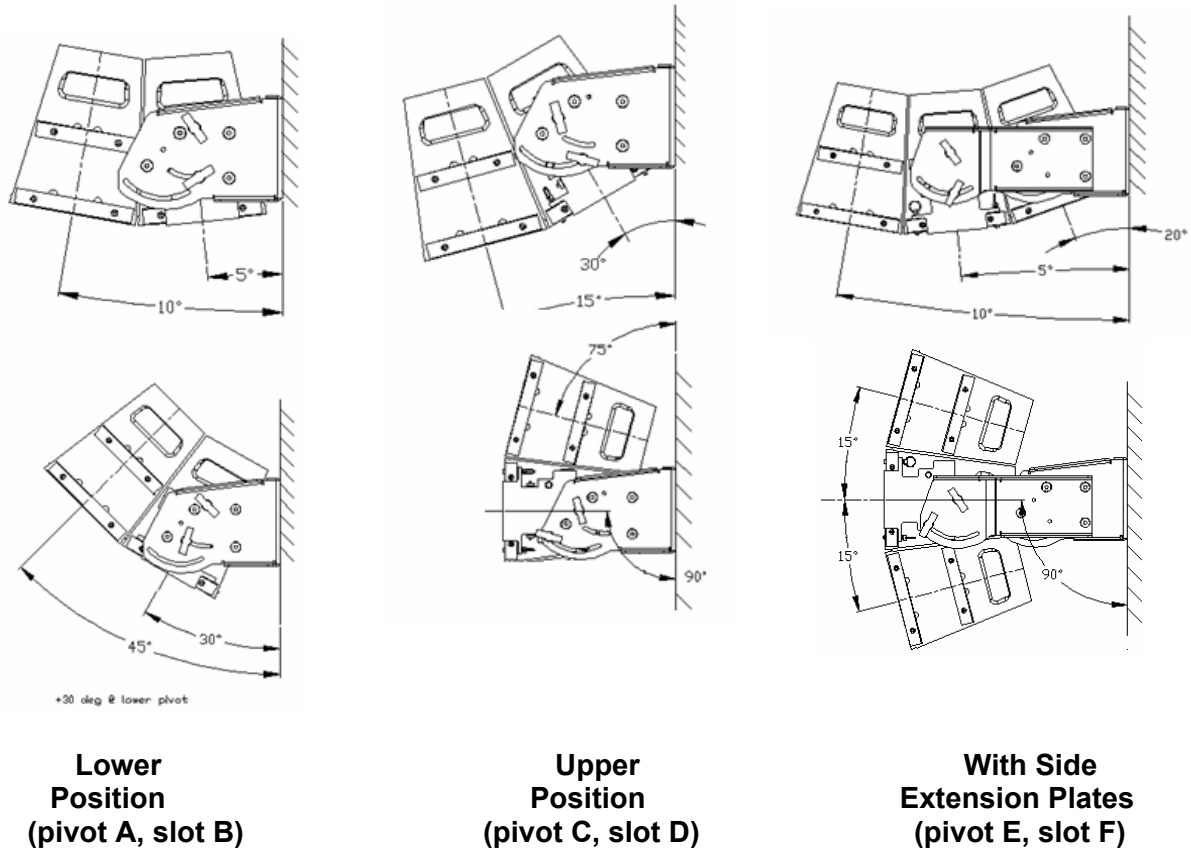
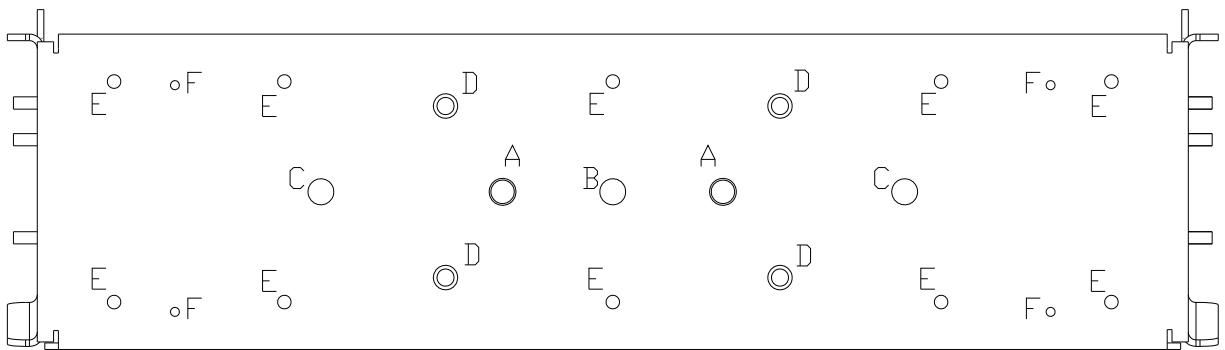


Figure 15: VT4886-UB Wall Mount Mode Examples (refer to Figures 16 and 18 for mounting options)

Figure 16: VT4886-UB Universal Bracket Base Attachment Options

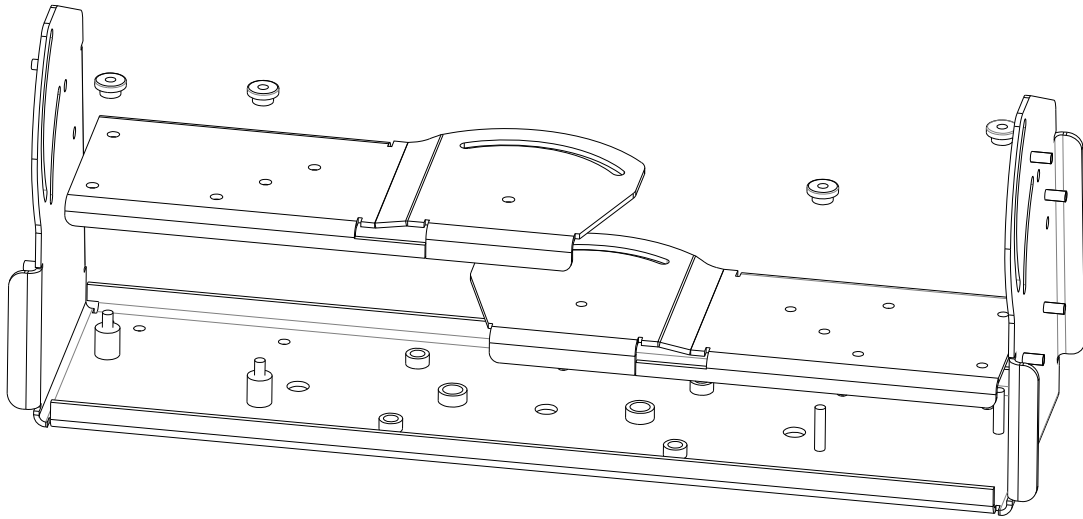


Figure 17: VT4886-UB Universal Bracket Side Extension Plate Storage Details

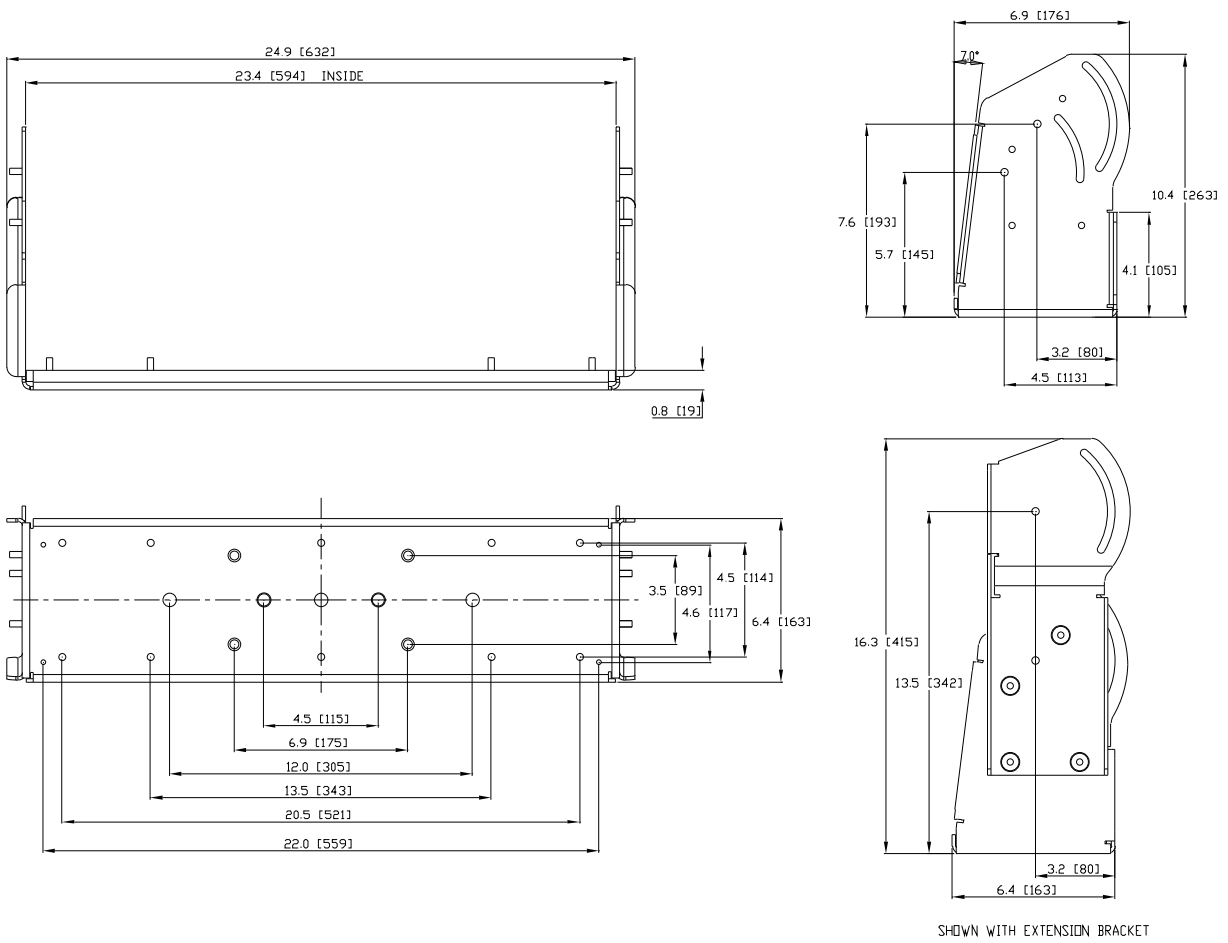


Figure 18: VT4886-UB Universal Bracket Dimensions

JBL WARRANTY AND INFORMATION

JBL amplifiers are warranted for three years from the date of original purchase. Enclosures and all other JBL products are warranted for two years from the date of original purchase.

WHO IS PROTECTED BY THIS WARRANTY?

Your JBL Warranty protects the original owner and all subsequent owners provided that:

A) Your JBL product has been purchased in the Continental United States, Hawaii or Alaska. (this Warranty does not apply to JBL products purchased elsewhere except for purchases by military outlets. Other purchasers should contact the local JBL distributor for warranty information); and B) The original dated bill of sale is presented whenever warranty service is required.

WHAT DOES THE JBL WARRANTY COVER?

Except as specified below, your JBL Warranty covers all defects in material and workmanship.
